Section 3. ANNUAL BUDGET ADOPTED: The annual budget for 1994, dated December 13, 1993 is hereby adopted. A copy of said budget shall be filed with the recorder-Treasurer and shall be available for inspection by any person.

Section 4. SEVERABILITY: If any part of this ordinance shall be held void, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this ordinance.
