

ORDINANCE NO. <u>2010 - 03</u>

AN ORDINANCE TO PROHIBIT DISCHARGING OF FIREARMS WITHIN THE CITY LIMITS OF PLEASANT PLAINS, ARKANSAS

This ordinance, effective 11 October 2010
shall prohibit the discharging of any rifle, shotgun, handgun or fire
powered weapon of any type, within the Pleasant Plains city limits, with
the exception of a shooting range, which is designated by the City of
Pleasant Plains and the City of Pleasant Plains Police Department, to be
a legal shooting range. Such range will not be maintained by the city,
nor will the city or the Police Department be responsible or liable in any
way for any accidents or injuries which may occur at such range.
Enforcement of this ordinance shall be at the discretion of the Chief or Officer of the Police Department or any other law enforcement officer as defined in Section 2(a) of the Arkansas Law Enforcement Standards Manual.
